



## College Assistance

### WHY YOU SHOULD HIRE ME:

Yes, I am not a former college admissions counselor. But that makes me an even better choice. This is why:

- I am an attorney and an expert writer. I worked for the federal government for 25 years in high-level positions.
- I have been working with students on college essays, law school applications, fellowship and internship statements, and the like, for close to eight years. I have never received a bad review and all my students have been successful.

**Essay Assistance** - Common and Coalition Application assistance. Zoom chats and email exchange. Set charge of \$300 for up to 4 hours; time spent over 4 hours will be billed at \$125 per hour.

**Supplemental Essays** - This can be added to the essay assistance. I keep a timesheet of work done and bill in 30-minute increments. I provide the timesheet to the student and parents before invoicing (\$250 per hour). Essay Assistance is also available for personal statements for graduate school, law school, fellowships, internships, et al.

### **School List**

This service is for families who want assistance determining a list of colleges ideally during Junior year of H.S. but are prepared to handle the rest of the college application process on their own. This service gives families three meetings (usually 1 hour each, unless pre-designed differently (additional charges may apply), and I prepare the list based on information generated between the parents and student (e.g. demographics, size of school, cost, places to visit, SAT/ACT strategy). Essay Assistance and/or Supplemental Essays can be added when the student is ready to apply. (\$2,500)

At the end of the process, a timesheet (if applicable) and invoice are generated, and payment is received by mail to Happy on Wheels or by paying online with a credit card.

### **All-Inclusive**

This service is for families that would like open-ended support tailored to the individual throughout the college admissions process. This program can begin as early as a family wants to start. The sooner the better. An initial meeting is used to outline all the services that are needed such as identifying colleges, figuring out how to learn about colleges online and in person, developing a spreadsheet of colleges to visit or contact, helping the student keep track of deadlines and monitor progress, assistance with executive planning and analysis, application assistance, essay writing, and anything else identified during the initial meeting. Tasks can be added throughout the process. This package includes the main essay and supplementals. It is all encompassing. (\$6,500)
